

Our Key Facts



We were established to address the challenges and barriers that rural and remote health professionals face when trying to take leave.

The Rural Locum Assistance Program (Rural LAP) supports rural and remote specialist and GP obstetricians and anaesthetists, nurses, midwives and eligible allied health professionals to take leave by providing their employers with access to locums to back-fill positions.

Rural LAP offers:

- A brokerage type service between hosts and locums
- No fees or charges
- Incentives and allowances for locum health professionals

How can I benefit from Rural LAP?

Rural LAP can provide a suitably matched locum for 14 working days (categories 2-7) for recreation and CPD leave and up to 28 working days for remote placements (categories 5-7) supporting recreation and CPD leave (noting that priority will be given to placements with a CPD component or located in MMM categories 6 and 7). We can also relieve multiple staff that need to get away at the same time.

Rural LAP is responsible for all the administration associated with recruiting appropriate locums. We also arrange and cover all payments for the locum's travel, accommodation, meals and incentives whilst on placement.

There are no fees or charges, the hosting organisation is only responsible for paying the base locum wage (including superannuation and any applicable taxes) for the period during which the locum is required. Please note that a minimum of two weeks notice is required for all placements.

Is my health service eligible to receive support?

Rural LAP will use the level of rurality and the purpose for the leave as criteria to prioritise applications for locum support.

Health professionals working in Aboriginal Medical Services, which are located in a major city, are also eligible.

In assessing the rurality of the locum placement, Rural LAP will be guided by the Modified Monash Model (MMM). Applicants must be located within the MMM Categories 2 to 7 and prioritised as shown below:

7. Very remote Australia
6. Remote Australia
5. Inner and outer regional Australia in all areas not classified below
4. Inner and outer regional Australia (10km away from a town with 5,000 to 15,000 people)
3. Inner and outer regional Australia (15km away from a town with 15,000 to 50,000 people)
2. Inner and outer regional Australia (20km away from a town with > 50,000 people)

Publicly funded organisations located between MMM categories 2 - 4 are not eligible to apply for locum support.

We are different from other locum programs

Our service is focussed on supporting health professionals by administering an uncomplicated start-to-finish locum placement service.

Types of support for the health professional host and the visiting locum

Subsidy	Conditions
Administration and recruitment fees for locum support	Max 28* working days per placement
Incentive for locum on placement	\$150 per working day during placement (excl. obstetrics & anaesthetics)
Travel and meal allowance for locum on placement	\$100 per day during placement
Travel and accommodation costs for locum	Arrangements made and paid for by Rural LAP
